# BYE LAW

• Eligibility for membership

Any male or female who is above 18 years of age and who is willing to work under the terms of this association and who has studied, taught or is teaching at St. Joseph's college of pharmacy can apply to become a member of this association

• Cessation of Membership

Any member shall cease to be a member on the acceptance of his resignation of membership by the executive committee of the association.

• Membership register

There shall be a membership register in which the name, qualification and address of all the members of the association shall be entered.

Management

The executive committee shall be composed of the following members of the association

Chairperson

The chairperson should be the Principal of St. Joseph's college permanently.

- President
- Secretary
- Treasurer
- Vice president
- Joint secretary
- Two executive members elected

The executive committee shall have general power of supervision, and conduct the overall affairs of the Association and in particular shall discharge the following duties:

- The entire responsibility of the activities of the society shall be vested in the administrative committee.
- Implementation of general meeting decisions, passes income and expenditure accounts, pair check the annual income- expenditure statements and balance sheet.
- Within 14 days of the annual general meeting, the certified copy of the income and expenditure accounts shall be submitted to the office of the District Registrar signed by the president, secretary and Treasurer or at least 3 members of the governing body.
- All the documents and records for the society shall be vested in the Governing body of the time being.
- Treasurer can keep the amounts up to Rs.5000/- in hand. If transactions above Rs.5000/- are made with bank in the name of the group, then the payment should be made only through the joint account of the President and Secretary.

### ELECTION OF OFFICE BEARERS

The election of the society can be done every three years by ballot collection, recorded in the minutes or by show of hands. Annual dues defaulters are not entitled to participate in voting.
