Author Guidelines

1. Scope of the Journal

JPIR publishes original, peer-reviewed research articles, reviews, short communications, and case studies in all branches of pharmaceutical sciences — including pharmaceutics, pharmacology, pharmacognosy, pharmaceutical chemistry, pharmacy practice, biotechnology, and related interdisciplinary areas.

2. Submission of Manuscripts

- Manuscripts should be submitted electronically through the journal's submission system or via email to editor. **sicpjournal@gmail.com**
- The corresponding author must certify that the manuscript is original, unpublished, and not under consideration elsewhere.
- A cover letter stating the type of article, ethical compliance, and conflict of interest declaration should accompany the submission.

3. Manuscript Categories

- 1. Original Research Articles Full reports of original investigations (3,000–5,000 words).
- 2. Review Articles Comprehensive reviews of contemporary topics (up to 6,000 words).
- 3. Short Communications Brief but complete studies (1,500–2,500 words).
- 4. Case Reports / Case Studies Descriptions of specific cases with clinical or scientific relevance (1,000–2,000 words).

4. Manuscript Preparation

All manuscripts must be written in English using Times New Roman 12-pt font, 1.5 line spacing, and A4 page size with 2.5 cm margins. The structure should include Title Page, Abstract, Introduction, Materials and Methods, Results, Discussion, Conclusion, Acknowledgments, Conflict of Interest Statement, and References.

5. Tables and Figures

Number tables and figures consecutively. Provide clear titles and legends. Figures should be in high-resolution (JPEG/TIFF, \geq 300 dpi).

6. Ethical Considerations

All studies involving humans must comply with the Declaration of Helsinki and have Institutional Ethics Committee approval. Animal studies must follow CPCSEA or equivalent guidelines. Authors must follow COPE ethical standards for publication.

7. Plagiarism Policy

JPIR uses plagiarism detection software (Turnitin/iThenticate). Manuscripts with >15% similarity (excluding references) will be returned for revision or rejection.

8. Open Access and Copyright

All articles are published under the Creative Commons Attribution 4.0 International License (CC BY 4.0). Authors retain copyright and grant JPIR a license to publish and distribute the work with appropriate attribution.

9. References — Vancouver Style

References must be numbered consecutively in the order of citation in the text and identified by superscript Arabic numerals. List all references at the end of the manuscript.

10. Article Processing and Publication

JPIR does not charge submission or publication fees. Accepted manuscripts undergo copyediting, proofreading, and DOI assignment prior to publication.
